## Important Tax Reminders for CCOM Students

Tax season is upon us again and there are a few of things that you should keep in mind when filing taxes.

- Don't forget to include your 1098-T form! This form shows the amount of tuition that you
  paid during that year and it can reduce your overall tax liability. This form can be found in
  MyUI (Look under the Financial Aid and Billings section—it will be listed as Hope 1098-T Tax
  info). Use the dropdown menu and select the appropriate year.
- Scholarships and Grants are generally <u>not</u> considered taxable income. This can be confusing to students that receive scholarships and grants from CCOM. It seems like you would need to include them on your taxes, but that is generally not the case. The only time that you would need to include your awards on your taxes is if the total amount of scholarships and grants were more than the cost of tuition. If you include your scholarships and grants on your taxes, it can create issues when you file your FAFSA and even decrease your eligibility to qualify for need-based grants.
- Need help filing taxes? The Tippie College of Business has a Volunteer Income Tax Assistance Program to help students with any questions or problems that they may encounter.

## **CARES ACT UPDATE**

- The CARES Act has been extended until the end of September. Your federal loans will continue to be interest-free during this time.
- There will also be another round of relief funding (called HEERF II) that students can apply for.
   Keep an eye on your email for more information about this—the email will most likely come from the main financial aid office.
